CERTIFICATE OF COMPLIANCE

CALIFORNIA PROPOSITION 65 WARNING REQUIREMENTS

California's Safe Drinking Water and Toxic Enforcement Act of 1986, more commonly known as "Prop 65", came into effect on August 30, 2018 requiring "CLEAR AND REASONABLE WARNINGS".

Spears® products are available in various sizes, quantities and package configurations making it impractical to label each individual part with the Prop 65 warning. Due to this, sales of Spears® products to California customers will need to provide a point-of-sale warning for those products that require Prop 65 labeling. These point-of-sale warnings are necessary for our PVC and CPVC pipe, fittings, valves, cements, primers and primer cleaner.

The various warning types are below. For Spears® distributors, these must be printed and placed where they will be visible to your customers in your California locations. The signs should be no smaller than 5 x 5 inches and printed in no smaller than 20-point type. Spears® distributors that offer Spears® products sold on the web are not exempt from this regulation and should comply accordingly.
